Engineering Report

Engineer Frank Ferris reported that the District began the month with a usable balance of 4,234 acre feet, before a possible allocation for the February period. The updated usable balance amounts to 50 percent of the annual water right and 35 percent of the storage balance. There was no allocation for January. The U.S. share is down to 29.7 percent as of March 4, 2023. The District has diverted 1,400 acre feet so far this year.

Engineer Frank Ferris completed the Water Conservation Plan Annual report for 2022 as required by the State.

Main Canal Piping at the McAllen Airport

Engineer Frank Ferris reported the completion of the main canal piping at the McAllen Airport except for some additional rip rap required at the headwall. The Second Lift is back in service and functioning properly.

OPEN SESSION:

A Motion was made by Lance Neuhaus and seconded by Chris Burns to amend the Employee Manual Policy in reference to sabbatical with same employee benefits available to the employees with corrections effective March 15, 2023. The changes are as follows:

HCWID #3 provides extended long term leave of absence without pay to any employee who the District can no longer employ due to budgetary restrictions or the unexpected unavailability of the current or similar position held by the employee. The duration of the extended long term leave will vary depending on the time it takes for the restrictions that imposed the leave to be removed or lifted upon the District and Employee. The District cannot guarantee the availability of future work or the restoration of the same job position the employee held before the employee's leave. However, if the restrictions are removed and a job becomes available, the District will extend an offer for the employee to return to work holding the same position, or an equivalent position for which the employee is qualified.

Upon the employee's return, the District will guarantee the same pay rate or better and the same Employee benefits available to the employee before the extended long term leave, provided those benefits continue to be available to all employees at the time of the employee's reinstatement.

Employees will be paid for all accrued annual leave time before taking an extended long term leave.

Subject to the terms, conditions, and limitations of the applicable plans, HCWID No. 3 will not continue to provide health insurance benefits, except for the continuation of health coverage under COBRA pursuant to State law.

Benefits accruals, such as annual leave, sick leave, and holiday benefits, will be suspended during the period of leave and will resume upon return to active employment. So that an employee's return to work can be properly scheduled, an employee on an extended long term leave will be provided 4 weeks advance notice of the date the employee is to return to work.

If an employee fails to return to work on the agreed upon return date, HCWID No. 3 will assume that the employee has rejected the employment offer to return to work.
