Chris Burns, Lance Neuhaus, and W.D. Moschel won the Election for May 7, 2022.

Eight provisional votes were counted, 6 for early voting and 2 were counted for Election Day. The election officials rejected them for the reason that improper or no identification was provided by the voters. In addition, votes rejected were also associated with property that was outside the District map boundaries or the names were not on the list.

Consideration and possible action regarding the Minutes for the Special Board Meeting on May 10, 2022.

General Report by President

No General Report by President was presented.

Engineering Report

Engineer Frank Ferris reported to the Board that there was no allocation for the April period. The Watermaster depleted 15,000 acre feet of the 75,000 acre feet reserve to balance; losses were much higher than inflows. The Usable Balance at the beginning of May was 4,478 acre feet or 52 percent of the annual water right, and 37 percent of the Storage Balance. The U.S. share has fallen to 37.1 percent as of May 7. The District pumped over 3,000 acre feet for the April period.

Engineer Frank Ferris informed to the Board that they completed and filed the Water Conservation Plan Annual Report with the Texas Water Development Board.

Consideration and possible action to amend the Budget for the Year 2021-22 to reflect

the change on the Maintenance Fringe Benefits.

A Motion was made by Mark Freeland and seconded by W.D. Moschel to amend the Budget for the Year 2021-22 to reflect the change on the Maintenance Fringe Benefits. (See Attachment D-2021-22 Amended Budget on the Maintenance Fringe Benefits)

Consideration and possible action regarding the approval of a License to the City of McAllen for a pedestrian trail at Highland Avenue and the Main Canal, Hidalgo, County. Texas.

A Motion was made by Mark Freeland and seconded by Chris Burns to table this item to allow the applicant to provide a survey and legal description of the property.

Item Tabled.

Consideration and possible action to release a right-of-way for Lateral M3, out of Main Canal, adjacent to Tamarack to the City of McAllen in exchange for a new right-of-way of the main canal and an easement.

A Motion was made by Mark Freeland and seconded by Chris Burns to approve the release of right-of-way to the City of McAllen for Lateral M3 out of the Main Canal adjacent to Tamarack in exchange for a new right-of-way in a different location and an easement to the District. (See Attachment "E" Deed and Easement documents).

Consideration and possible action for the approval of the McAllen Temple Subdivision Being 10.615 acres out of Lot 16 Section 13 Hidalgo Canal Company Subdivision, Hidalgo County, Texas.

A Motion was made by Chris Burns and seconded by Mark Freeland to table this item.

Consideration and possible approval of a license to the McAllen Public Utility for a 12" waterline crossing of the main canal at Kendlewood Avenue.

A Motion was made by Chris Burns and seconded by Mark Freeland to authorize Engineer Frank Ferris to write a letter to the City of McAllen Engineer, Carlos Gonzalez, with the following comments:

1. The Waterline crosses over the District's pipeline which is not allowed by the District. Utility License Guidelines and Fee Schedule (Guidelines), Item (6) requires a public water utility to cross below the District's pipeline.

- 2. The Guidelines, Item (3)(h) has not been adequately addressed. The Utility's Engineer must certify the elevation and the diameter of the District's pipeline and whether it has been field verified at the exact crossing or interpolated.
- 3. The clearance between the top of the proposed utility casing and the bottom of the District's pipeline shall be either 2 feet or 5 feet, depending on the certification in Number 2 above.

Consideration and possible approval of a license to the McAllen Public utility for a 12" waterline crossing of the main canal at Hackberry Avenue.
