### **Engineering Report**

a) Report on District allocation in the Falcon & Amistad Reservoir System.

Engineer Frank Ferris reported that the District began the month with a Usable Balance of 2,875 acre feet, amounting to 34% of the annual water right, and 24% of the storage balance. The US share is down to 21.9 % as of February 3<sup>rd</sup>.

The District currently has 4,055 acres of irrigation in account balances, which requires 2,703 acre feet of usable balance, so not enough in storage for an allocation with 1,000 acre feet operating reserve.

The Excerpts from an IBWC presentation identifying the US Penstock is out of commission forcing US to share the Mexican Penstock at a higher elevation, increasing the dead storage from 4,500 acre feet to 18,394 acre feet. Resulting reduction in the water for allocation is 14,000 acre feet. Schedule for repair for about 1 to 2 years.

- b) Las Milpas Road -Currently no updates.
- c) HCRMA Project- The work has been halted due to lack of materials and supplies.
- d) McAllen South Industrial Park Lateral F Canal Relocation Project Construction is ongoing.
- e) City of McAllen South 10<sup>th</sup> Street Drainage Improvements The work has not been completed.

Consideration and possible action to declare District Right of Way and Easement as surplus, and no longer needed by District 0.61 acres of Lateral U along the West Boundary of a 3.723 acre tract out of Lot 14, Ebony Heights Citrus Grove No. 1 Subdivision, Hidalgo County, Texas.

A Motion was made by Chris Burns and seconded by Mark Freeland to approve and to declare District Right of Way and Easement as surplus and no longer needed by District 0.61 of an acre of Lateral U along the West Boundary of a 3.723 acre tract out of Lot 14, Ebony Heights Citrus Grove No. 1 Subdivision, Hidalgo County, Texas.

Consideration and possible action to exchange a 0.28 acre tract out of Lateral F canal right of way along the West Boundary of 3.95 acres out of Lot 3, Section 4, Hidalgo Canal Company Subdivision for construction of a new underground pipeline.

A Motion was made by Lance Neuhaus and seconded by Chris Burns for HCWID #3 General Manager Joe De Leon and Engineer Frank Ferris to proceed and make the proposal as presented and place the pipeline into the adjacent right of way in exchange for the 0.28 acre tract out of Lateral F; canal right of way along the West Boundary of 3.95 acres out of Lot 3, Section 4, Hidalgo Canal Company Subdivision for construction of a new underground pipeline.

### Consideration and possible action to sell municipal water allocations.

A Motion was made by Chris Burns and seconded by Lance Neuhaus to approve the sell from the allocated water of 5,000 ac. ft. of municipal water rights contract of wet water authorizing President Othal Brand, Joe R. De Leon, HCWID#3 General Manager, and Engineer Frank Ferris.

Consideration and possible action regarding the District to approve a request by Texas Gas Service Lease Agreement for 100' x 4500, Temporary Parking Workspace between Dicker Rd and Las Milpas Rd located in South McAllen, Hidalgo County, Texas.

A Motion was made by Chris Burns and seconded by Lance Neuhaus to approve a temporary workspace permit by the Texas Gas Service with the condition to use the West Front entrance only between Dicker Road and Las Milpas Road in the South McAllen, for the term of three (3) months starting April 1, 2024 thru June 30, 2024. Upon the termination of the Permit shall promptly clear the temporary workspace of trash, litter and debris and restore the surface of the ground, of any damages made to its condition as it was previously was.

(iv) a pending McAllen Public Utility petition filed with the Public Utility

Commission of Texas appealing wholesale water rates of Hidalgo County Water Imp. District No. 3, (v) a pending lawsuit in Cause No. C-1601-22-1 styled "McAllen Public Utility vs. Othal Brand, Jr., in his official capacity, et al" and pending interlocutory appeal in Case No. 13-23-00020-CV in the 13th Court of Appeals, and (vi) contemplated litigation relating to to default by City of McAllen with respect to payment obligations pursuant to Permanent Water Supply and Delivery Contract, as amended, between Hidalgo County Water Improvement District No. 3 and City of McAllen.

The Board did not enter into executive session.
